 The final concession rates have been decided taking into account the raw material prices prevailed during the preceding quarters and the foreign exchange rate of the current quarter. The phosphoric acid price has been worked out as per the formula recommended by the Expert Group.

- The final concession rates for indigenous DAP Group I units are lower than the final concession rates for indigenous DAP Group II in case of 4th quarter of 2006-07. Accordingly, the final claims for the 4th quarter of 2006-07 in respect of M/s. Hindalco Industries Ltd. (Group I), PPL, SPIC and Tata Chemicals Ltd. (Group II) will be settled in proportion to the production of DAP made by these companies through the different route.
- The final concession rates for the 4th quarter of 2006-07 indicated above in respect of indigenous DAP and Complex fertilizers will not be applicable in respect of fertilizers produced by M/s. IFFCO, Kandla unit for which the relevant rates will be announced separately.
- The State Governments are requested to expedite pending sales 5. certificates to enable processing and payment of the outstanding claims of manufacturers/importers of P&K fertilizers.
- This issues with the approval of Finance Division of Department of Fertilizers vide their dairy No.C-1654/AFA/07 dated 27.4.2007.
