**Sub: Month-wise final rates of concession in respect of Mono Ammonium Phosphate (MAP) from September 2007 to February 2008 during 2007-2008.**

Madam/ Sir,

In continuation of this Department's letter No.19011/76/2005-MPR dated 30.10.2007 notifying the inclusion of MAP grade 11:52:0 and MAP 11:52:0 produced by granulating Imported MAP under the Concession Scheme for decontrolled P & K fertilizers with effect from 1.4.2007 upto 31.3.2008 and 22011/13/2007-MPR dated 19.5.2008 announcing the final concession rates for the months of October 2007 to February 2008, on the sales/receipts of decontrolled P & K fertilizers (DAP/MOP/NPK Complexes) during the year 2007-08, I am directed to say that the monthly final rates of concession for MAP for the period September 2007 to February 2008 shall be as follows during 2007-08:-

2. The final rates of concession for the months of April-August 2007 have not been announced since no claims have been preferred by any manufacturers/importers for these months before Department of Fertilizers.

3. The rates as above would be applicable for Imported MAP (11:52:0) and MAP (11:52:0) granulated Indigenously. No additional concession would be reimbursed for producing granular MAP (11:52:0) Indigenously.

4. The State Governments are requested to expedite the pending sales certificates/ certification of receipts of fertilizers to enable processing and payment of the outstanding claims of manufacturers/importers of MAP.
